## **IMPORTANT**


For students who have not received a Conditional Offer with us in March 2025, and who would like to be certain of their appeal being heard in the main round of appeals held in June 2025, this Notice of Appeal must be submitted by 12:00 noon on Friday 25th April 2025. Appeals submitted after this date will be heard without delay, and if at all possible, before the commencement of the September term, although this will be subject to when the appeal is made.

For students who wish to appeal following Results Day in August 2025, please note that Appeals can be made at any time, however we would recommend sending your Appeal to us during August so that it can be heard as soon as the independent panel are able after the return to school in September 2025.

**Please Note** - If the basis of your appeal is the due to the failure to reach specified entry requirements for the Sixth Form, the grounds for appeal are much more limited in line with the School Admission Appeals Code. This will be explained further in the Guidance Document that is circulated by the Appeals Clerk prior to your appeal.
